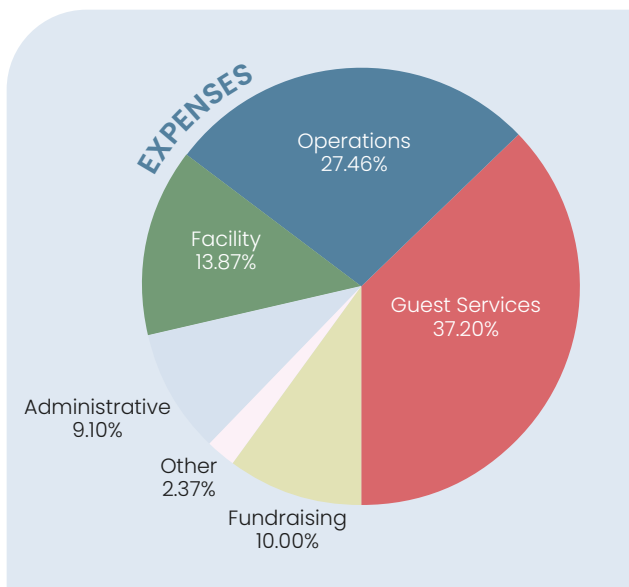

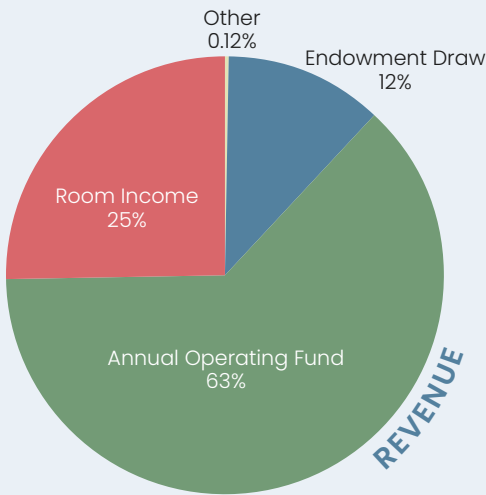

This year, we proudly surpassed our \$8.5 million Capital Campaign goal, marking a historic milestone in our journey and ushering in an exciting new chapter as SECU Caring House.
